5. The firm/company will be totally responsible for payments of any materials supplied against valid POs once shipped unless notice is given to us in writing canceling those purchase orders prior to shipment.
6. Re-seller is strictly forbidden from listing E&T Products on any 3rd party websites (Walmart, Home Depot...) and internet marketplace web sites such as (Amazon, eBay, Wayfair, Houzz...). Permission is only being given to sell within physical locations owned by applicant, its direct franchisees, and applicant's own website(s).
